

▲ Entertainment facilities (5types) ▲ Collatec-dance hall	(opearating time) Until 24:00 (density) no restrictions (available targets) those who are fully vaccinated (wether to eat or not) not possible (vaccination certificate negative confirmation system) mandatory
Singing(coin)practice room Bathhouse business Indoor sports facilities bicycle-racing racetrack- horse racing Casino	(operating time) no restrictions (density) no restrictions (available targets) those who are fully vaccinated (whether to eat or not) not possible (vaccination certificate-negative confirmation system) mandatory (indoor sports facility) possible to use shower room, music speed treadmill speed restrictions, etc. are lifted vaccination certificate-negative confirmation, introduction guidance period is 2 weeks (1 week for other facilities)
▲ Restaurant-Cafe	(operating time) no restrictions (density) keep distance 1m in between tables, one space off and or installing partitions (available targets) no limit (unvaccinated, maximum limit to 4 persons) (whether to eat or not) possible (vaccination certificate negative confirmation system) not applied
▲ Cinema-Performance hall	(operating time) no restrictions (density) one space between parties one space off only when for those who are fully vaccinated (available targets) no restrictions (whether to eat or not) not possible (movie theater) only those who are fully vaccinated can eat (vaccination certificate negative confirmation system) not applied
▲ Sports event(viewing)hall	(operating time) no restrictions (density) 50% of the capacity restriction of number of people is lifted when it consist of only those who are fully vaccinated. (available targets) no restrictions (whether to eat or not) not possible only those who are fully vaccinated can eat (vaccination certificate negative confirmation system) not applied
▲ Academy,etc.(if there are no seats) ▲ Arcade(game)room·Multi room	(operational time) no restrictions (Academy) period of 11.1.~11.21. maintain limit time 22:00, removal of time limit from 11.22 (density) facility report permission 1 person per 4m (available targets) no restrictions (wether to eat or not) not possible (vaccination certificate negative confirmation system) not applied

▲ Exhibition-Expo	Operating time) no restrictions density) no restrictions (available targets) select one of the following rules below to apply (mixed application is not allowed) less than 100 people regardless of vaccination less than 500 people who are fully vaccinated the previous rules (1 person per 6m² and PCR negative confirmation of a resident personnel in the booth) can also be applied on a selectively (wether to eat or not) not possible (vaccination certificate negative confirmation system) not applied
▲ International conferences Academic events	(operating time) no restrictions (density) spacing one seat (available targets) select one of the following rules below to apply (mixed application is not allowed) less than 100 people regardless of vaccination less than 500 people who are fully vaccinated * (international conferences) the previous rules (spacing 2 spaces between seats) can also be applied on selectively (wether to eat or not) not possible (vaccination certificate negative confirmation system) not applied
A Wedding, Birthday party, Funeral	Operating time) no restrictions (density) facility report permit 1 person per 4m of area, keeping a distance 1m between tables and or a space, or installing a partition (available targets) select one of the following rules below to apply (mixed application is not allowed) less than 100 people regardless of vaccination less than 500 people who are fully vaccinated (wedding ceremony) the previous rules (49 people + 201 fully vaccinated people) can also be applied on a selectively (wether to eat or not) possible (vaccination certificate negative confirmation system) not applied
▲ Religious facilities	(operating time) no restrictions (density) 50% of capacity no limit if composed only with fully vaccinated persons (available target) no restrictions (wether to eat or not) not possible (vaccination certificate negative confirmation system) not applied (others) prohibition of vocal prayers, etc, standards for general events apply to events other than regular religious activities (worship, etc.), small groups and choir are possible when only those who have completed the vaccinations.

^{*} Those who are fully vaccinated, etc.: those who are fully vaccinated, those who have negative PCR test (48 hours), those under 18 years old, those who have recovered, those who cannot be vaccinated due to health reasons, etc.
