▲ Wedding, Birthday party, Funeral	<ul style="list-style-type: none"> <li>· (operating time) no restrictions</li> <li>· (density) facility report-permit 1 person per 4㎡ of area, keeping a distance 1m between tables and or a space, or installing a partition</li> <li>· (available targets) select one of the following rules below to apply (mixed application is not allowed)</li> <li>- less than 100 people regardless of vaccination</li> <li>- less than 500 people who are fully vaccinated</li> <li>* (wedding ceremony) the previous rules (49 people + 201 fully vaccinated people) can also be applied on a selectively</li> <li>· (wether to eat or not) possible</li> <li>· (vaccination certificate-negative confirmation system) not applied</li> </ul>
▲ Religious facilities	<ul style="list-style-type: none"> <li>· (operating time) no restrictions</li> <li>· (density) 50% of capacity</li> <li>* no limit if composed only with fully vaccinated persons</li> <li>· (available target) no restrictions</li> <li>· (wether to eat or not) not possible</li> <li>· (vaccination certificate-negative confirmation system) not applied</li> <li>· (others) prohibition of vocal prayers, etc, standards for general events apply to events other than regular religious activities (worship, etc.), small groups and choir are possible when only those who have completed the vaccinations.</li> </ul>

\* Those who are fully vaccinated, etc.: those who are fully vaccinated, those who have negative PCR test (48 hours), those under 18 years old, those who have recovered, those who cannot be vaccinated due to health reasons, etc.

\*\* Eating is prohibited : prohibited except for water and non-alcoholic bevarages, if there are additional facilities (restaurants · cafes, etc.) where you can eat inside the facility, you can eat in that space.
